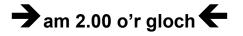

1. Background

- 1.1 The election of the Chair and Vice Chair of the Council is a statutory requirement under sections 22, 23 and 24 of the Local Government Act 1972.
- 1.2As a result of the <u>Coronavirus Act 2020</u> and the current pandemic, Welsh Government has passed <u>The Local Authorities (Coronavirus) (Meetings)</u> (Wales) Regulations 2020 (as amended).

1.3 Regulation 11 of <u>The Local Authorities (Coronavirus) (Meetings) (Wales)</u> <u>Regulations 2020</u> deals with "Election of chairs and vice-chairs of principal councils and community councils at annual meetings". This Regulation amends the provisions of the Local Government Act 1972 such that it reads as follows (underlined text is the wording included by the Regulations) -

22 Chairman (relevant part only).

(1)The chairman of a principal council shall be elected annually by the council from among the councillors <u>but if there is no election of a chair at the annual meeting of the council in 2020, the person holding office as chair immediately before the annual meeting of the council in 2020 may continue to hold office.</u>

23 Election of chairman (relevant part only)

(1)The election of the chairman shall be the first business transacted at the annual meeting of a principal council <u>unless</u>, in relation to the annual meeting held in 2020, the council decides not to hold an election of a chair at that meeting.

(1A) A principal council that did not elect a chair at its annual meeting held in 2020 may hold an election of a chair at any time before the annual meeting held in 2021 (but not after 30 April 2021)

2. Proposal

- 2.1 Due to the provisions in the Regulations, there is no requirement to elect a new Chair / Vice-Chair at the Council's Annual Meeting for 2020.
- 2.2A Council decision is required, at the Annual Meeting, so as to confirm that an election is not to be conducted for 2020.
- 2.3Where no election is held, the current Chair will continue to hold office until the Annual Meeting in 2021 (unless an election is held before then).
- 2.4 It is recommended that the current Chair and Vice Chair continue in their roles so as to ensure continuity. It should also be noted that, at least for the foreseeable future, the roles of Chair and Vice Chair will likely be restricted to the conduct of meetings and any constitutional, rather than civic/ceremonial roles; such activities having been suspended for now.

3. <u>Recommendation</u>

3.1 Council is asked to confirm that an election to select a Chair and Vice Chair for the Council is not required and that the current Chair and Vice Chair of the Council will continue in their roles for an extended term until the Annual Meeting for 2021.

ISLE OF ANGLESEY COUNTY COUNCIL

1. <u>Background</u>

- 1.1 In accordance with the Executive Procedure Rules (included in Part 4.4 of the Council's Constitution), "The Leader may amend the scheme of delegation relating to executive functions at any time during the year. To do so, The Leader must give written notice to the Chief Executive and to the person, body or Committee concerned. The notice must set out the extent of the amendment to the scheme of delegation, and whether it entails the withdrawal of delegation from any person, body, Committee or the Executive as a whole. The Chief Executive will present a report to the next Ordinary Meeting of the Council setting out the changes made by the Leader." (Paragraph 4.4.1.4.2)
- 1.2 As a result of the coronavirus pandemic, the Leader amended the scheme of delegation on 23rd March 2020. Details of the changes are included in paragraph 3.5 below.
- 1.3 This report is presented in accordance with paragraph 1.1 above and at the request of the Council's Internal Audit Service.

2. <u>Part 3 of the Council's Constitution – the scheme of delegation</u>

- 2.1 Part 3 of the Council's <u>Constitution</u> sets out the responsibilities in relation to decision making for various functions of the Council (the Council's scheme of delegation).
- 2.2 The Council's scheme of delegation is based on the principle that the Executive will exercise all of the local authority's decision making which have not been delegated to any other part of the local authority i.e. it will be an executive decision unless it has been noted, in law or under the Constitution, to be a decision of full Council, a regulatory committee or a decision for officers. This complies with the details included in Local Government Act 2000 and The Local Authorities (Executive Arrangements) (Functions and Responsibilities) (Wales) Regulations 2007 [which provides information on the decisions that (a) must not and (b) may not be for an Executive to make].

3. <u>Executive decisions</u>

- 3.1 Section 3.3 of the Constitution details items upon which decisions are to be made by the Executive. The delegation of executive functions lies with the Leader.
- 3.2 Executive decisions are made by the Executive as a whole, or may be made by individual members of the Executive (the Leader/Portfolio Holders), or Committees of the Executive, or officers acting under specific delegated executive authority.

3.3 Executive Decisions by Cabinet:

Executive Cabinet decisions are made in <u>the webcasted meetings</u> which are usually held monthly. The <u>decisions made</u> in each meeting are subsequently published.

3.4 <u>Portfolio Holder Decisions:</u>

Portfolio Holder decisions are made in accordance with the standing <u>Executive</u> <u>delegation</u> and in accordance with the <u>Job Description for Executive Members</u>

- **1.0** The Council needs to review political balance arrangements on its Committees annually. There is currently 1 vacant seat on the Coucil following the recent death of Cllr S Redmond. All by- elections have been postponed until 2021 in accordance with recent legislation as a result of the pandemic.
- **2.0** The Local Government and Housing Act 1989 sets out the main principles governing political balance, which are:

"(a) that not all the seats on the body are allocated to the same political group;

(b) that the majority of the seats on the body is allocated to a particular political group if the number of persons belonging to that group is a majority of the Authority's membership;

(c) subject to (a) and (b) above, the number of seats on the ordinary committees of a relevant Authority which are allocated to each political group bears the same proportion to the total of all the seats on the ordinary committees of that Authority as is borne by the number of members of that group to the membership of the Authority; and

(d) subject to paragraphs (a) to (c) above, that the number of the seats on the body which are allocated to each political group bears the same proportion to the number of all the seats on that body as is borne by the number of members of that group to the membership of the Authority."

3.0 The position in terms of Group Membership is as follows:

| Plaid Cymru Party of Wales | - 14 |

| Anglesey Independents | - 6 (This includes 1 Liberal Democrat Member) |
| Vacant seat | - 1 |

- **4.0** The attached Matrix sets out the entitlement of seats on each Committee.
- **5.0** The total number of seats to be allocated is 113.
- 6.0 Clearly, unless the calculation arrives at whole numbers of total seats overall and

the whole number of seats on each committee, then fractions will inevitably result, so that exact compliance will be impossible. It is, however, necessary to achieve the best possible compliance on the figures with the principles set out in paragraph 2 above.

- **7.0** Each political group on the Council can only allocate the seats it receives under the political balance arrangements to its own members and cannot allocate to a Councillor who is not a member of that same political group.
- 8.0 The attached Matrix sets out the overal entitlement of seats on Committees.
- 9.0 The overall entitement to the Anglesey Independents Group is reduced by (3) seats as a result of the vacancy.
- 10.0 In accordance with political managemeent protocols, Group Leaders have been consulted on political management arrangements.

8.0 Recommendations:-

- () The Council is requested to confirm political balance arrangements and the number of seats allocated to each of the Groups under the Local Government and Housing Act 1989.
- (ii) That Group Leaders advise the Head of Democratic Services as soon as possible if there are any changes to Group Membership on Committees.
