2 - Constituency Activity

I have attended all 10 meetings of the Trearddur Bay Community Council of which I am a member and have also attended meetings of the Rhoscolyn Community Council as an observer and local member. I represent the Council on the Governing Body of Ysgol Gymraeg Morswyn and have attended all meetings held since last March and also represent the Trearddur Bay Community Council on the Holyhead Joint Burial Board which is responsible for the management of the Maeshyfyd Cemetery.

I am also a member of the Shadow Governing Body of the new Ysgol Cybi and have attended 4 of the meetings held so far and the Wylfa Newydd Stakeholders Group and have attended all 3 meetings held.

I participate in the Holyhead Stakeholder Group which covers the economic regeneration of Holyhead under such initiatives as the Viable and Vibrant Places.

I am aware of the financial challenges facing the Council and take an active part in internal focus groups and workshops.

3 - Initiatives and Special Activities

I represent the Council on the Community Health Council and take an active interest in all health-related issues. I have carried out unannounced hospital inspections as part of that role. As a cancer patient, I am also an active member of the North West Wales Cancer Forum which focuses on patient centred care and have also attended the National Macmillan 'Cancer Voices' Conference and the National Lymphoma Association Conference and am also involved in the project to re-model the Alaw Ward in Ysbyty Gwynedd and am passionate about retaining local health services.

I take an active interest in all aspects of constituency life and am always willing to meet informally with electors to discuss any issues of local or personal concern e.g. waste, planning and highways issues, flooding, housing, amenities etc. and am available to contact by telephone, email or face to face. I refer issues to the appropriate departments on behalf of the electors in order to instigate dialogue and am grateful to the officers for their help and support in addressing and resolving these issues.

I am still involved in the 'community clean-ups' in Trearddur Bay arranged by the Residents Association who should be applauded on their success in improving the appearance of the village by cutting vegetation, disposing of rubbish and planting flowers, shrubs etc. This is an excellent way of bringing the community together to achieve something positive. I am also keen to retain our local facilities such as the football field and to improve the tourism offer in the area.

It is very good to see that 2 new Community Centres have opened in this ward at Maeshyfyd and Kingsland and that social housing schemes have been completed in the ward. I am very pleased that Viable Vibrant Places Grant Scheme now includes part of Trearddur and several local business and the football team have benefited.

A grant has also enabled the much needed footpath along Ravenspoint Road to be constructed and indeed Trearddur Bay has become a busy viable vibrant place.

Of course, I am also interested in issues which affect the island as a whole, e.g. the Wylfa Newydd, Orthios, National Grid and Land and Lakes applications along with social issues such as adult social care, education and, more recently, the identification of sites for gypsies and travellers and have attended several public meetings and briefings.
