Heading of Report - Play Sufficiency Assessment

1.0 Purpose of Report

In November 2012 the Welsh Government commenced the first part of the duty under section 11 of the Children and Families (Wales) Measure 2010, Play Opportunities for Children. The duty requires the Local Authority to assess the sufficiency of play opportunities for children within Anglesey.

2.0 Issues for Scrutiny

- To approve the contents of Anglesey Play Sufficiency and Action Plan.
- To discuss funding support to secure sufficient play opportunities by Local Authority and promote healthy, safe and fair communities.

3.0 Background

Welsh Ministers decided to commence the duty in two parts. The first part covers the duty on Local Authorities to assess for sufficient play opportunities.

Soon the second part of the duty will be placed on the Local Authority to secure sufficient play opportunities on Anglesey for children, so far as reasonably practicable, having regard to the assessments; and the duty to

publish information about play opportunities for children in their areas and keep the information up to date. This will be commenced after full consideration has been given by the Welsh Government to the Play Sufficiency Assessment and the Local Authority Action Plan for improving play opportunities on Anglesey.

4.0 Report

The Welsh Government want Wales to be a country where children are increasingly seen outside enjoying the benefits of play. They want to create a play friendly environment which provides time, space and permission for children to play. This will need parents, families and everyone in the community to recognise that play is of great importance in children's present lives and for their future development. This will need all these groups, together with Local Authority elected Members and Officers; and other decision makers and providers across many policy areas, to work together to remove barriers to children's play and make a real difference for children in their own streets and communities.

Conducting the Assessment – Play Sufficiency Assessment

As well as establishing a baseline of provision, the Play Sufficiency Assessment will enable the following:

- Identification of gaps in information, provision, service delivery and policy implementation
- Support the establishment of evidence to give an indication of distance travelled in relation to play sufficiency
- Highlight potential ways of addressing issues relating to partnership working
- The input and involvement of all partners increasing levels of knowledge and understanding
- A monitoring system which will involve and improve communication between professionals
- The identification of good practice examples
- Increased levels of partnerships in assessing sufficient play opportunities
- The identification of actions for the Securing Play Sufficiency Action Plan which accompanies the Play Sufficiency Assessment

A template has been produced to support a corporate appraisal of the matters that need to be taken into account as set out in the Statutory Guidance. The indicators listed within each matter are provided as sample indicators that should be amended to meet local issues as appropriate.

The Play Sufficiency Assessment must demonstrate that the Local Authority has taken into account and assessed the matters set out in The Play Sufficiency Assessment (Wales) Regulations 2012 and Statutory Guidance.

Working Group:

October 2012 - A briefing was held to help raise the profile of the Play Sufficiency Assessment process. The briefing provided an opportunity to identify the range of other factors and decisions that impact on children's opportunities to play in their communities on Anglesey.

December 2012 - First official Working Group meeting was held, partnership roles, responsibilities and timeline were discussed and agreed on. Key partners were identified to assist in completing the assessment included:-

January 2013 - Working Group met to analyse and prioritise future actions out of the Play Sufficiency Assessment. Group agreed to meet again in April to commence on completing the actions within the Action Plan. Sub-groups will be created to achieve tasks within each priority that has been identified, full working group will meet twice a year.

February 27th 2013 - Play Sufficiency Assessment and Action Plan will be presented to the Lifelong Learning Scrutiny to review and sign off.

March 14th 2013 - Play Sufficiency Assessment and Action Plan will be sent on and presented to the Executive Committee to be reviewed, signed off and agreed by elected members.

Partnership working

Representatives from the Town and Community Councils, Third Sector Organisations are part of the Working Group. All were invited to conclude a questionnaire on what play opportunities they offer or lead on within their communities.

Consultation and participation

Children and Young People's views were obtained through using Survey Monkey to collate their answers from the questionnaire provided from the Play Sufficiency toolkit. Over 600 questionnaires were answered 51% completed by boys and 49% by girls, their views have been valued in taking the Action Plan forward.Further analysis will be done on all questionnaires and uploaded on to GIS maps within the up and coming months.

Views on play provision were obtained from parents and families, 140 responses were received.

A summary of the questionnaires were summarised into graphs and presented to the Working Group to analyse and take into consideration and value whilst prioritising future actions within the Action Plan.

Questionnaires were also distributed to Town and Community Councils to get their view on maintaining their parks and designated play areas within their communities. 13 questionnaires were received back out of what could have been 40, a full assessment will now be taken over the Summer 2013 of all designated park areas within Anglesey.

A Play Provider and Services Questionnaire was also distributed although a total of 30 had answered the first 4 questions the remaining questions only 2 answered. A shortened version of the questionnaire will be created again soon to hopefully compile more answers.

Maximising resources

It's statutory that the Assessment was done, with the exception of Highways and Children and Young People Partnership all other partners support children's access to play opportunities as a bi-product of their day to day work.

There is good intention from our partners to assist and deliver on the Action Plan but within the capacity and current resources that we have as a Local Authority, it is almost impossible to deliver on all actions.

We forsee that the initial work capacity and funding will hold us back on how much we will be able to complete and develop all across Anglesey. We also feel it's hard to budget what costs will arise until the sub-groups commence on the work.

The Play Sufficiency Assessment and the Single Integrated Plan

Currently Anglesey and Gwynedd are in the process of developing a Joint Single Integrated Plan under the newly established Partnership Statutory Unit. Local Needs assessment were conducted in both counties prior to the commencement of the Play Sufficiency Assessment. The Play Sufficiency Assessment and Action Plan will be integrated into the planning, implementation review of the Gwynedd and Anglesey Joint Integrated Plan during its development in the up and coming months.

To further assist this process both Gwynedd and Anglesey Play officers are based within the new partnership unit.

General Comments: Providing for Diverse Needs

* The needs of disabled children cannot be fully quantified. They are ever-changing.

* Training of Universal Services staff is vital to ensuring inclusive provision

* Better use of Family Information Service in supporting families of Disabled Children to access both mainstream and targeted services.

* Inclusion to be encouraged from birth - playgroups and early years providers must reach out to families who are wary of introducing a child with additional needs to mainstream activities

* Specialist play provision not available in the early years

Although there seems to be some improvement in disabled children and young people being able to access play opportunities, it is still evident that there is not enough. Training for staff is poor, access to buildings is poor and an understanding of the young people's needs and disabilities is poor. Although most of the downfalls are due to finance and budget.

Specialist Children's Services provide day services for children and young people aged 4 years to 17 years old, within these service we encourage social and leisure skills along with play opportunities, however this is not providing the same opportunities for them as what they would achieve by accessing their local community resources as well as being able to enjoy various sports and leisure activities.

Any new project should conduct a Equality Impact Assessment, on any new policy, project or scheme.

Matter C: Space available for children to play: Open Spaces and Outdoor unstaffed designated play spaces

General Comments: Supervised play provision

An annual staff training seminar has offered continuous training for around 60 staff, to hold play sessions and improvised sports for young people.

A Service Level Agreement with the Urdd ensures that young people are trained to hold sports sessions for children. Consistently improving on targets.

A resource pack is provided for each youth club (38) to promote play sessions within clubs. Evidence that a high number of young people benefit from these opportunities. Feedback in reports from evening sessions from young people note that they enjoy using the resource pack.

Continuing to run training for staff on health and safety to ensure that staff can offer safe provision for young people. A number of aspects are amber because of the seasonal nature of the provision, not available all year round.

General Comments:

Structured recreational activities for children

Evidence suggests that the sports agenda on Anglesey is contributing to the provision of sufficient recreational activities for children.

'Sufficiency' in the Play Guidelines is defined as 'having regard to quantity and quality.' Re. quantity, due to the range of programmes provided (both during and after school), the evidence suggests that 'any child is able to play freely and take part in a range of recreational activities in their communities, at times and in places that meet their needs.' Re. quality, the evidence suggests (on the Play Guidance definition of 'quality' below) that our programmes are offering children the opportunity to freely experience the following:

- Other children of different ages & abilities (e.g. through courses, sessions, clubs, outreach schemes)
- The natural world (through a structured / measured Outdoor Adventure Programme)
- Challenge and uncertainty / opportunities for risk taking physically & emotionally (through sporting competition, 'off the wall' activities

such as surf-lifesaving, attaining badges & awards in swimming and gymnastics lessons, experiencing risk & exhilaration in the outdoors – climbing, biking, kayaking, coast-steering - linking with Youth Service's Duke of Edinburgh and Youth Achievement Awards.

An annual resource pack is provided to 38 youth clubs to provide art and craft sessions in clubs.

The curriculum in clubs includes targets to complete items regularly for the annual Arts Festival. Evidence that a high number of young people benefit from these programmes annually.

Through a Service Level Agreement, the Authority supports Urdd Gobaith Cymru financially to ensure that children and young people can participate in performance activities, dance, singing, art and craft and sports. Evidence of consistent improvement in targets.

Through a Service Level Agreement the Authority supports the Young Farmers to hold a programme of activities by young people for young people inclucing a whole range of performance, craft opportunities.

General Comments: Charge for play provision

Structured recreational activities do incur a cost to children and families in order for leisure centres to survive, however the overall rationale is to be 'cost effective' rather than 'profit making.' Sports Development does not have an income charging remit, as such and therefore many of their programmes are free at the point of entry (e.g. Free Swim) with W.G. Grant Aid paying facilities and coaches, where required.

The main cost to children for structured recreational activities is entry charges – however, there is a membership scheme available which offers up to 25% discount on production of a Leisure Membership Card. The cost of membership for 4-17 yr olds is £5.70 for a 12 month period, giving discounted access to all public- run leisure centres and outdoor facilities on the Island; membership for children 0-3 yrs is free.

Targeted schemes are used, whereby an Organisation will subsidise use of our facilities for children and young people (e.g. Flying Start, Genesis (crèche), Social Services, Women's Aid, Urdd, Parys Training, Youth Service, Di-gatref, Taith i waith, etc).

There are few examples of subsidy for transport (car Linc 'Ynys Mon' has been used in the past for Sure Start ante and post natal clients; free swim has subsidised small groups / school pupils to attend crash-course lessons) but generally rather than subsidising transport, the particular scheme will be free at the point of entry.

Need to undertake comprehensive training needs analysis.

Need to source other funds to carry on with such training, as grant funding does not last forever.

Anglesey Local Authority welcomes the final statutory guidance that has now been rationalised and places children and young people's participation within the context of the Single Integrated Plan. The statutory guidance for developing local single integrated plans "Shared Purpose - Shared Delivery" has been updated to include the duties in respect of local authorities to assess for sufficient play opportunities and to promote and facilitate participation by children in decisions of the authority which might affect them, and to publish and keep up to date information about its arrangements. (Children & Families (Wales) Measure 2010 sections 11 & 12)



Way forward

United Nations Committee has ratified and published a general comment on Article 31 of the United Nations Convention on the Rights of the Child (UNCRC) which highlights the importance of a child's right to play.

The article states:

"That every child has the right to rest and leisure, to engage in play and recreational activities appropriate to the age of the child and to participate freely in cultural life and the arts... Member governments shall respect and promote the right of the child to participate fully in cultural and artistic life and shall encourage the provision of appropriate and equal opportunities for cultural, artistic, recreational and leisure activity."

Anglesey will keep Article 31 in mind whilst working to improve opportunities for children and young people's play within the Local Authority area.

On the 30th of January the working group met and went through actions that were drawn down from the Play Sufficiency Assessment the group included:-

- Play Rangers & Play Officer
- Planning
- Family Information Services (Marketing)
- Highways and Transport

- Leisure Services
- Youth Services
- Participation workers
- Children and Young People Partnership Co-ordinators
- Property Department
- Voluntary and community Sector

Anglesey Play Sufficiency Assessment has identified a range of actions to inform the Action Plan. During the workshop the Working Group agreed the prorities that will be developed as part of the Action Plan. The group followed the recommended mechanism and criteria provided within the Statutory Guidance in order to prioritise Anglesey's Action Plan.

Factors that were discussed whilst considering which actions to prioritise were:-

- Pressing need (does it need to be done now?)
- Impact (will this action make a difference?)
- Target vulnerable groups) (i.e. deprived / rural areas)
- Considered children's / parents thoughts (questionnaire)
- Partners needed to complete action.
- Capacity to complete the work.
- Can we start immediatley / timescale
- Cost to complete.
- Realistic / achievable?

The Working Group will proceed to meet, it has been agreed that the next meeting will be held before the end of April 2013, during this meeting sub-groups will be created in order to commence working on the priorities within the Action Plan.

We forsee that the initial work capacity and funding will hold us back on how much we will be able to complete and develop all across Anglesey. We also feel it's hard to budget what costs will arise until the sub-groups commence on the work.
