I recently managed to gain funding from a local developer in order to give free Christmas hampers and toys through Mon communities first to people who were struggling during last Christmas. This of course with the support of local businesses in Llangefni or it wouldn't have been possible. I have held a local surgery in my town, again in order to remain contactable to my constituents. I keep a close contact with my political party especially the local AM in order to be fully informed on local and national challenges facing us.

Initiatives & Special Activities

I have assisted in many local activities meeting with my constituents and have sought to maximise funding opportunities to support local initiatives.

I have assisted in Bryngwran community to raise awareness of a dog fouling problem by getting a local company to sponsor information leaflets to be dispensed locally raising the importance of cleaning up after your dog and the dangers involved if you don't. I hope to carry on with this to other communities as it is a widespread problem.

I have assisted a local group on various clean-ups they have had by liaising with them and the waste management service to complete the tasks which have been extremely impressive and hope to carry assisting the group and the great work they do.
