## 6. Main Planning Considerations

#### **Principle of development**

Policy C7 of the Gwynedd Structure Plan states: "There will be a presumption in favour of renewable energy projects provided that the impacts upon the locality is acceptable to the local planning authority. Where applicable, the proposals should be supported by an environmental assessment."

Policy 45 of the Ynys Mon Local Plan states: "Renewable energy projects will be permitted where it can be clearly demonstrated that there will not be any unacceptable impact on i. Landscape character, ii. Sites of international, national or local importance for nature conservation, iii. species which are of nature conservation importance iv. the standard of amenity enjoyed by the resident and tourist population and vi. Essential public services and communications.

Policy 8B- Energy Developments of the Stopped Ynys Mon Unitary Development Plan states "Applications for the development of renewable and non-renewable energy resources will be permitted where it can be demonstrated that there will be no unacceptable adverse impact upon the environment. Preference will be given to the development of clean and renewable energy sources, but proposals for non-renewable energy

projects will be permitted if they encourage the maximum use of energy efficiency within their design.

The council's Supplementary Planning Guidance 2013 outlines criteria which proposed turbines should adhere to and emphasises the importance of protecting the landscape.

#### Landscape and Visual Impact

The site and proposal has been assessed and there is an objection to the turbine on Landscape and Visual amenity grounds in relation to its individual effect on views of the AONB towards Mynydd y Garn and the cumulative landscape effects with other energy infrastructure and development

#### **Residential Amenity**

Given the distance from the properties and their orientation it is not considered that the proposal would result in an unacceptable effect on the outlook of these dwellings or upon residential amenity.

- Significant adverse Landscape and Visual effects on the setting of the AONB in the region of Mynydd y Garn.
