3. Report summary

The Children and Young Peoples Plan 2011-2014 is the culmination of a consultation period and planning which began at the 'Gwyl Plant' in July 2010 with over 2,500 children and young people present.

A number of key national and local strategic policies and priorities were identified and the Plan provides all services and stakeholders with clear outcomes to be measured over the lifespan of the plan.

'Anglesey Life 2010' provides the needs assessment for the plan and in October 2010 a number of focus groups were held to ensure that the plan identified the priorities across a range of partnerships including the Local Safeguarding Children Board, Community Safety Partnership, Health and Well-Being and Social Care Board and the Community First Partnership.

The statutory consultation period from November 2010 to February 2011 resulted in an excellent response to the plan and the editorial board have adopted a number of recommendations made.

The Plan has also successfully passed an Equality Impact Assessment.

The Plan has been full consideration on two occasions by the Education and Leisure Scrutiny Committee, and we would like to thank the Members for their enthusiastic support during the process of formulating the plan.

The Children and Young People's Partnership will report on the Plan's progress regularly and the Partnerships thematic groups are currently working annual action plans. Steering Group.

An annual self evaluation document will be published at the the Partnership's Annual General Meeting.

The Isle of Anglesey's second Children and Young People's Plan sets out the **outcomes** the Partnership want to achieve over the next three years. The underlying theme of the Children and Young People's Plan is on tackling **Child Poverty**. The Isle of Anglesey Local Service Board (LSB) is leading on developing a Child Poverty and Social Inclusion Charter which aims to support families and ensure that all services contribute to improving the lives of children and young people.

The outcomes selected reflect the priories identified by:

- Over 2500 children, young people and families who attended the Children and Young People's Festival in June and July 2010.
- The Child Poverty Strategy Workshop and the re-launch of the Children and Young People's Partnership in June and September 2010
- Children and Young People's Plan Consultation Events held in collaboration with the Community Safety Partnership, Health and Well-Being and Social Care Board, Community First Partnership, Youth Justice Service and the Local Safeguarding Children Board, service providers and the voluntary sector.
- Anglesey Life 2010 Needs Assessment


An invitation

The story so far

The Isle of Anglesey Children and Young People's Plan 2011-2014 builds on the successes of the first plan and aims to address some of the shortcomings which have since been identified. The governance structure of the Isle of Anglesey Children and Young Peoples' Partnership is as follows:



In September 2010 the Isle of Anglesey Children and Young People's Partnership (CYPP) was re-launched with the aim of making the Partnership more effective in planning and delivering services to the children, young people and families on Anglesey. In October 2010 the Strategic Partnership formally adopted the Specialist Children's Service (SCS) as a sub group of the Partnership. Each **Core Aim** in this plan highlights some of the achievements identified since 2008.

How we aim to achieve our outcomes

Three outcomes have been identified for each core aim. The Children and Young People's Plan identifies the actions required to ensure that we deliver on each Outcome. The need to develop and implement the following strategies has been recognised as being essential in the delivery of the Children and Young People's Plan:

- **Family Support Strategy**
- **Early Support Strategy**
- **Joint Commissioning Strategy**
- **Anti Bullying Strategy**
- **Arts and Culture Strategy**
- **Young People's Accommodation Strategy**
- **Workforce Development Strategy**
- **Childcare Strategy**

The thematic groups of the Children and Young People's Partnership (CYPP) will be responsible for monitoring the progress of the Children and Young Peoples' Plan. All thematic groups will formulate an annual action plan to support and co-ordinate the activities of partners and to identify and respond to gaps in services. The CYPP will also build on existing good practice in delivering services through joint funding and multi agency collaboration and sharing of resources. The CYPP have identified the need for a Joint Commissioning Strategy as a priority and will work closely with the Community Safety Partnership (CSP), The Local Safeguarding Children Board, Health Social Care and Well-being Board, Community First Partnership in planning and delivering services with particular regard to rural areas. Over the next three years the CYPP will also explore further opportunities for cross partnership collaboration.

How will we measure our success?

Under each core aim the CYPP has identified a number of indicators which will ensure effective monitoring of the progress of the Children and Young Peoples' Plan. Each indicator highlights the priorities of the CYPP and the performance of services accessed by children, young people and families. The CYPP has adopted a new **Quality Assurance Framework** and **Service Level Agreement** to ensure that the indicators are a focus at all levels of delivery of service. Over the next three years the CYPP will continue to support Quality Assurance training for providers.

A key focus of the Children and Young People Plan is to ensure that the performance of the CYPP is communicated effectively. These will be reported by various media and communication mechanisms. The CYPP has recognised a number of indicators it will seek to develop. The indicators will be listed on our **Data Development Agenda**.

For example, **Core Aim 1** may look like the following:

What will success look like if we achieve our outcomes?

1. Number of enquiries to the Family Information Service will increase.
Number of enquiries April 2011-June 2011 = 1300 –on target
2. Improved baselines of children starting school.
Data Development Agenda – on line September 2011

Who will help us to achieve our outcomes?

Under each core aim the CYPP has identified some of the **partners** who will assist in delivering the Children and Young People's Plan (this list is not exhaustive). Each Partner will have their own detailed action plan which will contribute to the overall delivery of the Children and Young People's Plan. The action plans will also identify the budgets and resources which will contribute towards the delivery of the Plan. An annual Self Evaluation report in line with the **Estyn Inspection Framework 2010** will be published which will allow stakeholders to review the performance of the Partnership over the course of the plan.

To provide every child on the Isle of Anglesey a flying start in life so that they may reach their full potential

- Flying Start established in all designated areas

- Childrens Centre established in Llangefni
- A referral Programme providing support for children with additional needs
- Child immunisation rates have continued to be amongst the highest in Wales.
- Reduction in teenage pregnancy rates
- Majority of Primary Schools operate the free breakfast initiative funded by Welsh Assembly Government (WAG)
- Healthy Pre Schools Programme launched successfully in 48 pre-school settings
- Number of enquiries to the Family Information Service has doubled in the last three years.







- Authority implementing the School Places Rationalisation Plan.
- The rate of attendance in primary school is above the Welsh average, in secondary schools the levels have improved at a faster rate than across Wales over the last 3 years.
- Collaboration between the secondary schools, the Education and Leisure Department, Coleg Menai and training providers and the voluntary sector in response to the 14-19 agenda
- The implementation of the Welsh Baccalaureate (BAC)
- Ysgol y Môr environment project for children and young people aged 8-14
- Percentage of pupils leaving schools without a recognised qualification has decreased
- Rates of permanent and fixed term exclusions have been reduced over the last 3 years.
- Introduction of 'Team around the Child' model
- Energy Island Initiative targeting retention of young people on the Island and up-skilling them for future employment.
