- 1.2 Periodically it is necessary to update the list by adding to it. On this occasion the legislation to be added is:-

- CH2 Changes to the "Note", referring to the definition of "day", which follows the Index at the beginning of the Constitution.
- 2.1 Currently the "Note" states Note: The reference throughout this Constitution to a "day" excludes Saturdays, Sundays, Bank Holidays and official Council holidays (which holidays include the period between Christmas and New Year plus St David's Day).
- 2.2 Following the Public Holiday which was announced for the Royal Wedding earlier this year and in order to avoid any misunderstanding the definition of "day" should also exclude ad hoc Public Holidays.
- 2.3 It is therefore proposed that the "Note" should be amended as follows:

Note: The reference throughout this Constitution to a "day" excludes Saturdays, Sundays, Bank Holidays, ad hoc Public Holidays and official Council holidays (which holidays include the period between Christmas and New Year plus St David's Day).

the "Note" to the form in CH 2.3 above and to authorise Officers to make any consequential amendments to the Constitution.
