#### **CH - Summary**

#### 1.0 **Background**

- 1.1 The Executive's forward work programme enables both Members of the Council and the public to see what key decisions are likely to be taken by the Executive over the coming months. The forward work programme includes information on the decisions sought and who the lead Officers and Portfolio Holders are for each item. It also now covers a longer period than the four-month periods on which it was based originally so as to strengthen forward planning arrangements.
- 1.2 The Executive's draft Forward Work Programme for the period November 2102 April 2013 is attached.
- 1.3 It should be noted, however, that the work programme is a flexible document as not all items requiring a decision will be known that far in advance and some timescales may need to be altered to reflect new priorities etc. The list of items included will therefore need to be reviewed regularly. Both strategic and operational issues are covered to inform the scrutiny process. Some items are likely to be determined by Portfolio Holders under delegated authority.

### 2.0 Role of Scrutiny
