2. WELCOME

The Chair welcomed Sarah Rochira the Older People's Commissioner for Wales and those attending the meeting in relation to item 3.

3. ATTENDANCE OF THE OLDER PEOPLE'S COMMISSIONER FOR WALES

The Older People's Commissioner attended the Board meeting in order to secure a better understanding of the work achieved by LSB's, to ensure that the future Public Service Boards (PSBs) reflect the needs, concerns and priorities of older people. The visit was further used to inform the LSB about the Ageing Well in Wales Programme and how the Board can better support older people through the Well-being of Future Generations (Wales) Act, 2015.

Ffion Johnstone presented to the Board details of progress made on the LSB's Key Priority Area 1 – Older People. The following points were noted:

- The Ageing Well agenda is essential to ensure Older People are able to continue to do the things that are important to them.
- The needs, concerns and priorities of older people will be met in particular through the Social Services and Wellbeing Act and the Future Generations (Wales) Act.
- Engagement with older people about public services is identified as a priority

RESOLVED

• To note the Older People's Commissioner's satisfaction with the progress made under KPA1.

4. MINUTES OF MEETING HELD ON 12th FEBRUARY 2016

The minutes of the Local Services Board convened on 12th February, 2016 were confirmed as being an accurate record of the discussions.

5. LSB KEY PRIORITIES - updates

5.1 Key Priority Area 2 – Creating Resilient Families:

Llio Johnson reminded members that this priority has been transferred to the Social Services Wellbeing work stream.

RESOLVED

The Board agreed with Siobhan Jones' proposal to present the Board with a report to consider whether the issue of childhood obesity should replace KPA2 at the next PSB meeting to be held in June 2016.

5.2 Key Priority Area 3 – Sustainable Communities / Community regeneration:- THE WELSH LANGUAGE IN PUBLIC SERVICES:

Arwel Ellis Jones provided the Board with a progress report, the following points were noted:

- The group have agreed to pause the work in order to give appropriate consideration to which areas they should concentrate upon. It is considered that the level of provision of Welsh language services to residents should receive be prioritised and receive greater attention.
- The members of the Workplaces Group, that includes representation from the LSB, have been requested to name a senior officer within their organisations to attend the Project Board to assess the degree to which their organisation are able to commit to this field of work. The level of response to this request for information has been disappointing
- The group wish to know if the Board are willing to commit to a consistent standard across public services in Anglesey and Gwynedd.

RESOLVED

- Members of the Board namely, Bangor University; North Wales Fire and Rescue Service and Grŵp Llandrillo Menai are asked to commit to providing names for that initial meeting that would set the direction for the project.
- Board members offer their support in principle to aim for a consistent standard across public services, but noting that organisations will be starting at different levels.

5.3 KPA3 - Sustainable Communities / Community Regeneration: ASSET SHARING:-

Geraint Hughes provided the Board with a progress report, the following points were noted:

- Initial scoping is being undertaken by partners to identify existing assets which are to be sold or made available for lease.
- On completion of the scoping work it is proposed to identify a means by which each organisation can share existing and future asset needs with each other to allow for suitable use to be made of available premises.

6. ASSESMENT OF LOCAL WELLBEING

Llio Johnson provided the Board with a progress report, the following points were noted:

- A sub group to lead on the work of compiling the local assessment has been established and met on 4th March, 2016 with representation from Gwynedd Council, Anglesey County Council, Fire and rescue Service, Bangor University, Third Sector and Public Health Wales with representatives from Natural Resources Wales and the Health Board attending the next scheduled meeting to be held in May, 2016.
- The research and Analytical team in Gwynedd Council will be providing the starting point of identifying the indicators and populating the wellbeing matrix.
- The Partnerships Unit are collating information from local consultations.
- The sub group will consider the National Indicators Welsh Government is clear that individual Boards will not be measured against these indicators but they will be included in the Local Assessment if the sub group identify them as *local* indicators.
- A grant of £45,000 has been received from Welsh Government towards preparing the Local Wellbeing Assessment – this grant is being shared between the 4 Boards in North Wales. The North Wales Public Service Board managers in North Wales are meeting to prepare a project plan for the grant. Conwy Council have been identified as the authority that will manage the grant on behalf of the 4 Boards.

RESOLVED

 Sub group will meet on 18 May, 2016 to discuss and agree on draft indicators – to be shared at the end of May to initiate discussions at the Public Services Board meeting in June, 2016.

7. DRAFT PROGRAMME FOR THE ARRANGED WORKSHOP

Llio Johnson shared a draft programme for the arranged workshop with Board members scheduled for 24 May, 2016. Board members will receive a workshop pack two weeks prior to the meeting to enable Board members to have internal discussions beforehand

- All Board members to discuss any matters internally within own organisations prior to commencement of workshop on 24 May, 2016.
- Sioned Rees to feedback to Board on voting rights.

It is noted that this is the final Anglesey and Gwynedd Local Services Board meeting making way for the Public Services Board which will commence in May, 2016.
