Disclosure of this information will weaken the Council's negotiating position in the event of a sale.</i> <i>Additionally, the report contains financial / business information relating to the Council and to third parties. This has the potential to place the Council, and the public purse, at a disadvantage in the event of any future commercial negotiations relating to disposal of the site otherwise than by way of a freehold sale.</i>
