<p><b>Argymhelliad</b> - Mae'r budd i'r cyhoedd wrth gadw'r eithriad o bwys yn fwy na'r budd i'r cyhoedd wrth ddatgelu'r wybodaeth. <b>Recommendation</b> - The public interest in maintaining the exemption outweighs the public interest in disclosing the information.</p>
