Standards The Committee considers applications dispensations for from Councillors and determines if any legal ground may be relied upon such that the Councillor is able to fully or partly participate in the discussion and/or vote in the matter, despite their prejudicial interest. Therefore, the process of considering applications for dispensation is closely connected with a reasonable expectation of transparency in respect of the matters discussed.

> The application by the Community Councillor includes information relating to a particular individual. It includes personal details including the Community Councillor's address.

> The application also includes information which is likely to reveal the identity of an individual. The application includes details that, in a local community, could lead to individuals being recognised although not named. There is a strong public interest in ensuring that the process of considering an application for dispensation is undertaken in a manner that does not breach a public authority's statutory duties under data protection legislation.

> The subject matter on which the Councillor has requested the dispensation includes information that relates to possible future action to be taken in connection with the prevention, investigation or prosecution of crime in the local area.
