#### 1. WELCOME

### 2. MINUTES OF THE MEETING HELD ON 24 MAY, 2016

The minutes of the Local Services Board convened on 24<sup>th</sup> May, 2016 were confirmed as being an accurate record of the discussions; however, it was noted that following the Gwynedd Public Services Board meeting on 17 June, 2016 the Boards are keen to collaborate in order to prevent duplication, to show full commitment from the start and as both areas are so similar in nature. Collaborating as one Board is imperative in order to develop the Well-being Plan and conduct an assessment of well-being and is more inclusive for partners.

#### 3. DRAFT TERMS OF REFERENCE

Board members read through the ToR and the following points were noted:

- Appendix A: point 7; should read: The required resource for the implementation of the agreed objectives will be agreed by all the statutory partners once the objectives have been set.
- 4.5 to include paragraph to confirm that sub-groups must report to the PSB.
- 1.5 needs to be strengthened;
- 3.5 to read: "to the extent to which the law allows us, Board members will be equal members of the Board. We will treat all members of the Board as an equal member."
- 3.4 change The North Wales PCC to OFFICE of the Police and Crime Commissioner.
- 3.4 change The Chief Constable of North Wales Police to North Wales Police **REPRESENTATIVE**.
- 4.1 to include sentence to reflect that the Board should meet as separate Boards post elections and re-agree on collaborating / merging as appropriate.
- 4.6 to read "Each sub group of PSB should include one member or DEPUTY of the Board".
- 7.2 include that meetings will be open to the public **AT APPROPRIATE TIMES** such as AGM's.

#### **RESOLVED**

 To maintain 'Terms of Reference' as a standing item on future agendas as appropriate.

#### 4. MEMBERSHIP

PSB members agreed to extend an invitation to other agencies/organisations to be members of the PSB; namely:

#### **RESOLVED**

 Members agreed to assess membership whilst work is carried out on the wellbeing assessment. Llio, on behalf of the PSB, to invite the agreed agencies/organisations to attend future meetings.

#### 5. COMMUNITY AREAS FOR WELL-BEING ASSESSMENT

Llio Johnson provided the Board with a progress report, the following points were noted:

- For the purpose of conducting a local wellbeing assessment Anglesey would consist of 6 Community Areas and Gwynedd would consist of 8 Community areas.
- Engagement on well-being assessment will be carried out during the autumn.
- The Partnerships Unit are collating information from local consultations dating from 2014.

#### **RESOLVED**

- Community areas should be depicted on one map in order to illustrate collaboration.
- Communication sub-group to meet to prepare communications for wellbeing assessment engagement.
- Communication sub-group membership to be shared with PSB members.
