1.0 Purpose of the report

- 1.1 The purpose of this report is to:
 - Set out the key issues, challenges and opportunities faced by Anglesey over the Plan period;
 - Set out a vision for the Island over the period of the new Local Development Plan (LDP); and
 - Set objectives for the new LDP that will help realise the vision.

2.0 Decision required

2.1 Endorsement by the Committee of the Key Issues, Vision and Objectives Paper as the basis for preparing the draft Preferred Strategy for the new Anglesey LDP.

3.0 Reason for the decision

3.1 The paper plays a key part in developing the preferred strategy for the new Anglesey LDP.

4.0 Background and relevant considerations

- 4.1 The paper (**Appendix 1**) was shared with Members of the Planning Policy Committee who have had the opportunity to review it. To date, no responses to the paper's content have been received.
- 4.2 The paper identifies 17 key issues and challenges faced by the Island, covering a wide spectrum of interests and clear and realistic objectives have been formulated to address the issues concerned and these objectives contribute to setting the vision for the LDP. The vision reads as follows:

By 2039, Anglesey will be an Island of vibrant, lively, bilingual and engaged communities where people choose to live, work and visit, committed to the resilience of its economy, culture, heritage, environment and natural resources and to health and wellbeing.

4.3 The issues can be divided into environmental, economic and social categories as illustrated in the following table:
