I shall then arrange for a member to contact the school to arrange a mutually convenient time and date. The purpose of the visit is for the member to join in with the worship not to lead; the members are keen to be with staff and pupils so as to get an impression of the pupils' experiences in this key area.

If you wish you could show examples of pupil work to the visitor but there is no intention to turn the visit into a form of inspection.
