REPORT BY:	INTERIM HEAD OF DEMOCRATIC SERVICES					
PURPOSE OF REPORT:	TO ADDRESS THE QUESTION OF POLITICAL BALANCE FOLLOWING A REDUCTION IN THE MEMBERSHIP OF ONE GROUP					

- 1.0 The Council needs to review the political balance arrangements on its Committees following notice that 1 member has ceased to be a member of the Independent Group, the subsequent formation of a new Revolutionist Group consisting of 2 members and notice that 1 non-affiliated member has joined the Independent Group.
- 2.0 The Local Government and Housing Act 1989 sets out the main principles governing political balance, which are:

"(a) that not all the seats on the body are allocated to the same political group;

(b) that the majority of the seats on the body is allocated to a particular political group if the number of persons belonging to that group is a majority of the Authority's membership;

(c) subject to (a) and (b) above, the number of seats on the ordinary committees of a relevant Authority which are allocated to each political group bears the same proportion to the total of all the seats on the ordinary committees of that Authority as is borne by the number of members of that group to the membership of the Authority; and

(d) subject to paragraphs (a) to (c) above, that the number of the seats on the body which are allocated to each political group bears the same proportion to the number of all the seats on that body as is borne by the number of members of that group to the membership of the Authority."

3.0 Recent changes do not alter the political balance on the Council. The position remains the same as reported to the Council on the 5<sup>th</sup> December 2013:-

Unaffiliated	-	2

- 4.0 The attached Matrix sets out the entitlement of seats to each group and the seats to non-affiliated members in accordance with local convention as confirmed by Council on the 5th December 2013.
- 5.0 In accordance with political management protocols the revised political management arrangements have been discussed with Group Leaders.

## 6.0 **Recommendations:**

- to confirm the political balance arrangements and the number of seats allocated to each of the Groups under the Local Government and Housing Act 1989, and the number of seats given by custom and practice to the Members not subject to political balance as set out in the matrix;
- (ii) in accordance with recommendation (i) above, the Council delegates to the Chief Executive in consultation with Group Leaders to determine the allocation of seats to the Unaffiliated Member arising from these changes and advise the Interim Head of Democratic Services accordingly.
- (iii) that the Independent Group Leader be requested to provide details of committee membership to the Interim Head of Democratic Services as soon as possible in accordance with the changes in membership noted in this report.


